



**PROCEDURE FOR SEEKING ADMISSION TO MD/MS COURSES UNDER FOREIGN INDIAN STUDENTS (NRI) QUOTA
in Private Medical colleges of PRIVATE UNIVERSITIES of UTTARAKHAND (INDIA)
SESSION - 2025-26**

As per Uttarakhand Government notification no 330278/XXVIII(5)/2025-(E-78579) dated 12/09/2025. 15% seats of All India Open Quota of Shri Guru Ram Rai Medical Institute of Medical Sciences, Dehradun shall be earmarked for the Non Resident Indian. (Details enclosed as Annexure-I)

All admissions of NRI Quota shall be based on the merit of National Eligibility-cum - Entrance Test (NEET PG -2025)

For ascertaining the eligibility relevant documents including Foreign Country Passport or Green Card or Permanent Resident Card or Proof of Residency of Foreign Country issued by competent authority or OCI/PIO Card issued by the Government of India Shall be taken into consideration (Detailed Sample Format is attached Annexure-II)

The priority of Allotment Under NRI Quota will be as per conditions mentioned in the Uttarakhand Government notification No- 330278/XXVIII(5)/2025-(E-78579) dated 12/09/2025. All the relevant documents in support of eligibility and NRI category will be verified by allotted College at the time of admission
