PG Medical Courses Admissions – Second Round Seat Allotment (non In-service)

PGNEET-2025 Second round seat allotment for admission to PG Medical courses will be conducted for the seats which remained unfilled / cancelled / forfeited / newly added seats if any issued by Government, after first round seat allotment.

Candidates who have been allotted seat in the first round who have exercised Choice 2 & paid the fees, opted Choice-3 and those candidates entered the options but did not get the seat are eligible to participate in the second round seat allotment for admission to PG Medical courses by depositing the original documents at KEA, Bangalore as per the schedule given in the next page.

For the convenience of the candidate, modification of the options will be allowed as per the CHOICES of the first round. However, only those candidates who deposit the original documents as per the schedule given on the next page will be considered for the allotment of PG Medical seats in the second round. If a candidate fails to submit the original documents to participate in the second round for PG Medical seats, such candidates will not be considered for the allotment of PG Medical seats in the second round even if they have entered their options for PG Medical seats in the first round.

- As the cancelled/forfeited/newly added seats are announced from time to time, candidates are advised to keep checking the KEA Website for updates for availability of seats.
- KEA shall not be responsible for any action / consequence/s resulting due to non-diligent follow up of notices, notifications and publications appearing on the KEA website about seat allotment.
- Further, during the allotment the seats which may arise are also considered for allotment. Therefore, candidates are advised to retain all the options they are interested in choosing irrespective of the seats shown in the seat matrix.
- The candidate is advised to keep a printout of the list of options submitted finally.

SECOND ROUND OPTION ENTRY and SEAT ALLOTMENT SCHEDULE

All eligible candidates will be allowed to re-order the options based on the first round CHOICE selection for second round. If a candidate fails to deposit the original documents to KEA as per the above schedule to participate in the second round for PG Medical seats, such candidates will not be considered for second round PG Medical seat allotment even if they have entered the PG Medical options in the first round.

- Candidates can alter / delete / rearrange / modify the higher order options.
- Candidates are advised to enter only such options, if the seat is allotted, they have to compulsorily join the selected college in the second round seat allotment without giving any further EXEMPT, because the seats will be allotted based on rank / merit and the priority of options entered by the candidates.
- If candidate decides that unwanted options are there in their option entry list, he / she can delete it at consultation with their parents.

NOTE: Consequential vacancies that arise during the allotment after the candidate merit / turn cannot be claimed.

Virtual Vacancies:

- The seat held by CHOICE-2 of first round candidate will be declared as virtual vacancy.
- If any Choice-2 candidate of first round upgraded in the second round, vacates the first round seat.
- That vacated seat will be offered to the next eligible candidate in this second round provided such options are available in the candidate option entry list. Hence, all the second round eligible candidates are advised to retain such options if they are interested.

PLEASE NOTE:

- There is no choice selection in round 2, hence the candidates who get allotment in the second round have to compulsorily report to the allotted college as the seat allotment is based on the priority of options as entered by the candidates.
- The Choice 2 candidates of first round, if the seat is upgraded will report to the new college or if the seat is not upgraded, will report to the previously allotted college.
